#### 1. Service

The mare \_\_\_\_\_ Reg. No. \_\_\_\_\_

Will be bred to the stallion, **CHALANI CHAPARRAL**, for a fee of \$ \_\_\_\_\_. A non-refundable booking fee of \$ \_\_\_\_\_ will be paid prior to the arrival of the mare at Hillbro and will be deducted from the service fee.

#### 2. Accounts

An account listing all charges including the remainder of the service fee will be payable within seven days of positive pregnancy testing or upon removal of the mare, whichever ever comes first. Agistment will be \$25 per week per mare. If a mare has not been removed within seven days after notification to collect, agistment will increase to \$10 per day unless by prior arrangement.

#### 3. Veterinary Attention

All except pregnant and virgin mares must be swabbed and have a veterinary certificate confirming freedom from breeding infection, prior to being served, at the mare owners expense. All veterinary fees with regard to the mare's well being will be billed directly to the mare owner.

#### 4. Return Rights

Should the mare slip or fail to produce a live foal, Hillbro must be notified within 48 hours of foaling. Hillbro will accept the mare for free return service during the same season, upon payment of \$450 handling fee and the usual agistment. Hillbro does not undertake to keep any mare for longer than three consecutive cycles unless otherwise negotiated. If a mare in foal is neglected or undergoes any veterinary interference which terminates the pregnancy, this contract becomes null and void.

#### 5. Approval of Mares

##### **ALL MARES MUST ARRIVE UNSHOD AND IN GOOD HEALTH**

Preference is given to mares of sound confirmation, temperament and performance. All mares may be run with the stallion but hand service is usual for maiden or difficult mares. If in the opinion of Hillbro a mare is of doubtful temperament, breeding type or health, Hillbro will request her removal and all fees and accounts will become due and payable.

#### 6. Sale of In Foal Mares

If at the time of sale the mare is no longer pregnant, or in good health, this contract becomes null and void. A veterinary certificate at the time of sale is recommended.

#### 7. Liability

Whilst every care is taken, Hillbro shall not be liable for any accident or injury occasioned to the mare or her foal at foot, while at stud, nor will the mare owner be held responsible for any injury occasioned to the stallion. Insurance of mares is recommended.

#### 8. A.S.H. Certification

All progeny of Chalani Chaparral may be registered with the Australian Stock Horse Society upon payment of A.S.H. membership fee, foal registration fee and presentation of the official stallion Service Certificate, or upon A.S.H. Society approval if the progeny is from unregistered dams.
